The Subcontractor waives, releases, and relinquishes all liens and all claims and rights of lien which he has or may have against the Owner or the Property arising out of the Contract,
amendments, and change orders thereto and all work, services, equipment and materials performed or furnished by the Subcontractor and by all other persons on behalf of the Subcontractor.

The Subcontractor agrees to promptly pay and release of record all mechanic's and materialman's and like liens filed by any of the Sub-subcontractors, material suppliers or laborers in
connection with the work, services, equipment and materials performed or furnished under the Contract, amendments and change orders thereto to the effective date set forth below which
now or in the future affect the Property and to defend, indemnify and hold the Owner harmless from any liability or expense incurred because of any such liens or the enforcement thereof.
